

**IN THE MATTER OF THE ENVIRONMENTAL ASSESSMENT ACT S.B.C. 2002, c.43  
(ACT)  
AND  
AN ENVIRONMENTAL ASSESSMENT OF THE  
PROPOSED WCC LNG PROJECT (PROPOSED PROJECT)  
ORDER UNDER SECTION 13 AMENDING SECTION 11 ORDER**

**WHEREAS:**

- A. On January 7, 2015, under section 10(1)(c) of the Act, the Project Assessment Manager issued an Order to WCC LNG Project Ltd. (Proponent), determining that an environmental assessment certificate is required for the proposed Project, and ordering that the Proponent may not proceed with the proposed Project without an environmental assessment certificate.
- B. The Executive Director has delegated to the undersigned, powers and functions under the Act, including the power to issue orders under sections 11 and 13 of the Act.
- C. On April 27, 2015, the Project Assessment Manager issued an Order under section 11 of the Act, determining the scope of the required environmental assessment and the procedures and methods for conducting the assessment.
- D. Part G of the section 11 Order describes Aboriginal Consultation for the proposed Project, including aspects of consultation undertaken by Environmental Assessment Office (EAO), procedural aspects undertaken by the Proponent.

**NOW THEREFORE:**

Pursuant to section 13 of the Act, I order that the section 11 Order is amended as follows:

- (1) Amend the definition of “Working Group” to include reference to Aboriginal Groups listed in Schedule D.
- (2) Amend section 4.1, 7.2, 8.1, 10.1, 12.1, 13.1, 13.2.1, 13.3, 13.3.1, 13.3.2, 13.3.3, 13.3.4, 13.4 and 15.2 to include reference to Schedule D to these requirements.

Add a new section 12.3:

12.3 In addition to the consultation activities set out in 12.1, EAO will undertake additional measures throughout the environmental assessment in collaboration with Aboriginal Groups identified in Schedule D.

(3) Lax Kw'alaams Band and Metlakatla First Nation are added to Schedule D.

(4) Gitga'at First Nation is removed from Schedule C and added to Schedule B.

The updated Aboriginal consultation schedules pursuant to the section 11 Order are as follows:
