ORDER TRANSFERRING A CERTIFICATE

WHEREAS:

- A. On October 26, 2015, the Minister of Environment and Climate Change Strategy and the Minister of Energy, Mines and Low Carbon Innovation issued a Certificate to Woodfibre LNG Limited to construct and operate the Project, a liquefied natural gas (LNG) export facility at Woodfibre, British Columbia, approximately 7 km west-southwest of Squamish, British Columbia.
- B. On October 25, 2020, the Chief Executive Assessment Officer extended the date specified in the Certificate by which the Certificate Holder must have substantially started the Project to October 26, 2025.
- C. On August 22, 2022, Woodfibre LNG Limited applied to the Chief Executive Assessment Officer to transfer 30 percent interest in the Project to Enbridge Inc. and to transfer the Certificate to Woodfibre LNG General Partner Inc. under Section 33(1) of the Act.

D. According to the application, the date for the transfer is October 14, 2022 (Transfer Date).

E. As a result of this Order, Woodfibre LNG General Partner Inc. is the holder of Certificate #E15-02 as of the Transfer Date and is responsible for complying with all terms and conditions of the Certificate.

NOW THEREFORE:

I order as follows:

- 1) I consent to the transfer of 30 percent interest in the Project to Enbridge Inc. as of the Transfer Date;
- 2) I transfer the Certificate from Woodfibre LNG Limited to Woodfibre LNG General Partner Inc. effective as of the Transfer Date subject to Conditions (3) and (4) below.

CONDITIONS

- 3) Woodfibre LNG Limited provide a written confirmation to the EAO regarding Enbridge receiving a 30 percent minority interest in the Project. The transfer of the Certificate will not occur until such documentation is received.
- 4) Written acknowledgement from Woodfibre LNG General Partner Inc. that it understands that it must comply with the Conditions in this Certificate. The transfer of the Certificate will not occur until such documentation is received.
