WHEREAS:

- A. The Nisga'a Nation, Rockies LNG Limited Partnership, and Western LNG LLC proposes to construct, operate and decommission Ksi Lisims LNG as described in Schedule A to this Certificate (the Project).

- B. On March 16, 2023, the chief executive assessment officer of the Environmental Assessment Office published a notice of decision under Section 18(1) of the Act stating that the Project would be considered under Section 19 of the Act.
- C. On September 3, 2024, the revised Application was accepted under Section 27(4) of the Act.
- D. Compliance with this Certificate, including its conditions, will be monitored by the staff of the Environmental Assessment Office and others who have been authorized to inspect under the Act.
- E. On August 07, 2025, pursuant to Section 29(1) of the Act, the chief executive assessment officer referred the revised Application, the assessment report dated August 07, 2025, the chief executive assessment officer's recommendations, the proposed Environmental Assessment Certificate, and the notifications by participating Indigenous nations and Nisga'a Nation of the Nation's consent or lack of consent to issuing the environmental assessment certificate to the undersigned.
- F. The undersigned have considered the revised Application, the assessment report, the recommendations of the chief executive assessment officer, the proposed Environmental Assessment Certificate, and the notifications by participating Indigenous nations and Nisga'a Nation of the Nation's consent or lack of consent to issuing the environmental assessment certificate.

NOW THEREFORE,

We issue this Environmental Assessment Certificate to Ksi Lisims LNG Tolling GP ULC, on behalf of Ksi Lisims LNG Tolling Limited Partnership, for the Project as described in the Certified Project Description (Schedule A), subject to the conditions set out in the Table of Conditions (Schedule B).
